Survivors include his parents, Mr. and Mrs. Burdette Persson, Strawberry Point; a sister, Mrs. LaVern (Carolyn) Meiners, Eltzen, Minn.; a niece, two nephews. Preceding him in death was a sister who died in infancy.

Bus Dispute Goes To Court

DUBUQUE (AP) — Dubuque County District Judge Thomas Nelson has scheduled a hearing for Saturday in the dispute of school bus drivers and the Dubuque Community School Board.

The School Board has requested a temporary restraining order and injunction to end the walk-out of the 40 drivers who refuse to work because of a wage demand.

The hearing has been set to determine if the work stoppage violates the drivers' contracts and the state law prohibiting strikes against government agencies.

The drivers are represented by the United School Bus Operators Association. They failed to report for work Wednesday and Thursday.

Don Schoentag Wins Four Top Photo Awards

Don Schoentag, Oelwein master photographer who owns and operates Cottage Studio on First Avenue, N.E., was busy at work in his darkroom working on six large black and white prints he planned to enter in state competition at the Professional Photographers of Iowa convention when the tornado struck Oelwein.

Six of the photos were taken to the basement when the Schoentag family rushed for their basement — five of the prints survived the devastation.

Of the five prints taken to the convention held at the Savery Hotel in Des Moines May 19, 20, and 21, four were awarded ribbons as follows: Children's Portraits, 1st place for black and white; Group Portraits, 1st place (B&W); Open Class, 2nd place (B&W); and Honorable Mention to Schoentag's Men's Portrait entry.

The professional photographic artists of Iowa chose Schoentag's "Lisa" as the photograph all colorists in the state will color next year for their oil-coloring competition.

The awards for Cottage Studio now number 33 for state, national and international competition since 1962.

Files Court Action At Spencer

DES MOINES (AP) — The Iowa Water Pollution Control Commission has decided to file court action against the city of Spencer for allegedly failing to abate pollution of the Little Sioux River.

Commission Chairman Robert Buckmaster said Thursday the city was to have submitted plans for enlarging sewage treatment facilities by May 1, but failed to do so.

Spencer built a sewage treatment plant in 1960 under a state permit that specified the proportion of industrial waste to other waste could not be greater than five to one.

The commission was told waste from a packing plant now exceeds that proportion.

Red Cross Sets Sights On Long Range Program

As the need for emergency assistance nears an end in the area affected by last week's tornadoes, Red Cross disaster relief efforts are turning to the long-range recovery needs of the hundreds of families affected by the catastrophe.

According to Mrs. Charles Hutchison, chairman of the South Fayette County Red Cross Chapter, there are still weeks of hard work ahead for the Red Cross and for the stricken families of the ill-fated cities of Oelwein and Maynard.

Mrs. Hutchison emphasized that the Red Cross will remain on the job to help the more than 1100 families affected by the disaster in those cities.

"Our emergency assistance of supplying food, shelter, clothing and medical care is only the beginning," she said. "Now we take on the even bigger job of helping with the long-range needs of the victims so that they can resume their normal lives and places in the communities."

Mrs. Hutchison noted that this recovery assistance is approximately 75 per cent of all Red Cross disaster expenditures.

"Giving help to those who need it, is the job that the American Red Cross is on hand to do," she said. "If disaster victims have problems and needs they cannot handle themselves, we want them to come to disaster headquarters here in Oelwein. We have experienced Red Cross workers here to discuss individual problems and develop plans to get victims back on their feet by using their own resources and Red Cross help."


