The Dowlen Road wildfire began around 1202CST around ten miles south southwest of Canyon Texas in Randall county just east of the intersection of Dowlen Road and Farm to Market Road 1705. The wildfire consumed approximately two hundred and forty acres and the cause of the wildfire was determined to be from the use of welding equipment. There were no reports of homes or other structures damaged or destroyed and there were no reports of injuries or fatalities. A total of four fire departments and other fire agencies, including the Texas A&M Forest Service and the Randall County Fire Department, responded to the wildfire. The wildfire was contained between 1600CST and 1630CST.

The Wayside Road wildfire began about eight miles west of Wayside Texas in Randall county around 1501CST just east of Parsley Road between Farm to Market Road 285 and County Road 418. The wildfire consumed approximately two hundred and ninety-six acres and the cause of the wildfire was determined to be from downed power lines. Although no homes were threatened, damaged or destroyed, three out buildings were reported lost. There were no reports of injuries or fatalities from the wildfire. The wildfire was contained between 1900CST and 1930CST and there were a total of five fire departments and other fire agencies that responded to the wildfire, including the Texas A&M Forest Service and the Randall County Fire Department.

The River Wildfire began about fourteen miles east of Valley de Oro around 1440CST near U.S. Highway 287 and the Canadian River and burned on both sides of the highway. The wildfire did shut down the highway north of Amarillo due to poor visibility in smoke. Although the wildfire threatened two homes, no homes or other structures were reported to be damaged or lost. There were also no reports of injuries or fatalities. The wildfire consumed an estimated one thousand seven hundred and fifty acres and was fully contained by 1958CST on Sunday January 31. Several fire departments and other fire agencies responded to the wildfire, including the Texas A&M Forest Service.
