The Payne Wildfire began around 1230CST roughly thirteen miles east of Beaver Oklahoma in Beaver County. The wildfire consumed an estimated three hundred and thirty-six acres and there were about five homes threatened by the wildfire but were saved. There was a report that a couple of barns were destroyed, however there were no reports of any injuries or fatalities. The wildfire was contained around 1930CST.

A surface quickly moving northeast through the northwest Panhandles helped to develop snow along the north and northwest side of the upper level low pressure. In-conjunction with strong winds due to the deepening surface low, winds increased causing blizzard conditions for a few hours across the northern OK Panhandle, especially near the border of Kansas and Colorado. Conditions improved approaching the evening hours of the 23rd.

The Haggared Wildfire began near the intersection of north Farm to Market Road 283 and south Farm to Market Road 2699 in Roberts County about eight miles north northwest of Codman Texas at approximately 1430CST. The wildfire consumed two thousand two hundred and nineteen acres. The towns of Miami, Canadian and Gem City, and also Wheeler County along with the Texas A&M Forest Service responded to the wildfire around 1434CST. There was also aerial suppression support provided for the wildfire. There were reports of any injuries or fatalities and also no reports of any homes or other structures threatened or destroyed by the wildfire. The wildfire was contained around 1745CST.

The wildfire was brought under control around 1644CST.

The 2161 Wildfire began about four miles northeast of Washburn Texas in Carson County at approximately 1618CST. The wildfire consumed three hundred and eighty-six acres. The Claude Fire Department, Potter County Fire-Rescue, Panhandle Fire Department, Pantex Plant Fire Department, Texas A&M Forest Service, and Washburn Volunteer Fire Department responded to the wildfire. There were reports that three homes and one other structure were threatened by the wildfire but were saved and there were also no reports of any injuries or fatalities. The wildfire was brought under control around 2000CST.
