Competitive Sourcing (OMB Circular A-76)

1 Introduction

This Instruction describes the National Weather Service (NWS) competitive sourcing responsibilities and procedures.

2 Office of Management and Budget Circular A-76

The Executive Office of the President, Office of Management and Budget (OMB), issued a revised <u>OMB Circular No. A-76</u>, *Performance of Commercial Activities*, on May 29, 2003. This Circular describes the procedures and policies associated with requirements of the Federal Activities Inventory Reform (FAIR) Act and policies and procedures for A-76 studies.

3 Roles and Responsibilities

• The Assistant Administrator for Weather Services has overall responsibility for Circular No. A-76 activities;

• The Office of the Chief Financial Officer provides guidance and coordination on the Federal Activities Inventory Reform (FAIR) Act and Circular No. A-76 matters; and

• The Financial Management Center (FMC) conducting a competitive sourcing A-76 study is responsible for planning and carrying out the study in accordance with OMB Circular No. A-76 and other federal regulations.

4 Moratorium on A-76 Studies in the current Appropriation Act

SEC. 741. None of the funds appropriated or otherwise made available by this or any other Act may be used to begin or announce a study or public –private competition regarding the conversion to contractor performance of any function performed by Federal employees pursuant to Office of Management and Budget Circular A-76 or any other administrative regulation, directive, or policy. <u>https://www.congress.gov/bill/116th-congress/house-bill/1158/text</u>
