Subject: Changes to Marine Zones for WFO New York, NY (OKX):
 Effective March 30, 2021

On or about Tuesday, March 30, 2021, at 09:00 AM Eastern Standard Time (EDT), 1400 Coordinated Universal Time (UTC), the NWS Weather Forecast Office in New York, NY (OKX) will split marine zone ANZ330, the Long Island Sound East of New Haven CT/Port Jefferson NY, into two marine zones using a line from the mouth of the Connecticut River to Orient Point, NY.

If March 30, 2021 is declared a Critical Weather Day by the NWS, this implementation will be postponed to April 01, 2021.

These changes have been made in coordination with the United States Coast Guard and other partners and stakeholders. This modification to the marine zones will enhance safety and improve marine forecast and warning services provided to the marine community in the far eastern portion of Long Island Sound.

The current marine zone of will be converted into two separate zones.
