Subject: Removal of AutoNowCaster Products from the Multi-Radar, Multi-Sensor Application: Effective September 6, 2023

Effective on or about September 6, 2023, the AutoNowCaster (ANC) products will be discontinued and removed from the Multi-Radar, Multi-Sensor (MRMS) application. ANC currently provides two products: 1) Convective Likelihood, which indicates regions where new storm initiation and/or the growth/sustainment of advecting storms is more, or less, likely, and 2) Final Forecast, which indicates 60-minute extrapolation of existing storms with reflectivities ? 35 dBZ (including growth and decay), and areas where new storms are likely to initiate, with three levels of new storm initiation.

Comments/feedback on this proposed removal were previously solicited publicly from February 17, 2023 through March 19, 2023 via this Public Information Statement:

and yielded no objections to the discontinuation of the ANC products.

ANC was incorporated into MRMS in the mid-2000s and is no longer being actively supported or upgraded. In addition, increasingly, similar types of information are now being provided by other models, such as the High Resolution Rapid Refresh (HRRR) model and the Localized Aviation Model Output Statistics (MOS) Program (LAMP) forecast guidance.
