BEGINNING JUNE 1 2006 AND CONTINUING THROUGH NOVEMBER 15 2006...  
THE NWS IS SEEKING USER COMMENTS ON THE TROPICAL CYCLONE EXTREME  
WIND WARNING TEXT PRODUCT.

THIS PRODUCT WILL BE ISSUED PRIMARILY BY COASTAL WEATHER FORECAST  
OFFICES USING EXISTING TORNADO WARNING AWIPS AND WMO HEADINGS.  
THE PRODUCT TYPE LINE IN THE MASS NEWS DISSEMINATOR HEADER BLOCK  
WILL STATE TORNADO WARNING. HOWEVER THE BODY OF THE WARNING WILL  
REFER TO EXTREME SUSTAINED WINDS EQUAL TO OR EXCEEDING 115 MILES  
PER HOUR ASSOCIATED WITH A LANDFALLING HURRICANE.

BEGINNING JUNE 1 2006 A COMPREHENSIVE DESCRIPTION AND A STATIC
