Amended to change comment period to September 23, 2014

NWS is seeking comments on Experimental International Tsunami Products for the Pacific Basin through September 23, 2014. The Pacific Tsunami Warning Center (PTWC) is testing graphical and forecast statistical products that enhance information provided to non-US Pacific countries, with the exception of Canada. These products are issued for information only in support of the UNESCO/IOC Pacific Tsunami Warning and Mitigation System.

This graphical and statistical threat information will only be sent by email to a country's designated Tsunami Warning Focal Point (TWFP) to support decision-making by that country's tsunami warning organization. The existing Tsunami threat messages will also be included within the email. The tsunami warning organization may use the PTWC information as primary or supplemental guidance for determining their level of alert and is responsible for issuing applicable alert levels such as warnings and watches to its own emergency management and stakeholder agencies, and/or the public.

-Coastal Tsunami Amplitude Forecast KMZ: input to Google Earth

-Table of Forecast Statistics for Regional Polygons
