THE NWS RECONFIGURED A NUMBER OF PUBLIC ZONE FORECAST AREAS IN MONTANA ON  
OCTOBER 4 2000. AT 1100 COORDINATED UNIVERSAL TIME /UTC/...5 A.M. MDT...  
CUSTOMERS WHO USE UNIVERSAL GEOGRAPHIC CODES /UGCS/ TO SELECT WEATHER  
INFORMATION FOR SPECIFIC ZONES IN MONTANA NEEDED TO CHANGE SOME UGCS.  
TABLE 1 BELOW LISTS THE ZONES WHICH WERE IMPLEMENTED OCTOBER 4.

THE PURPOSE FOR RECONFIGURING WEATHER FORECAST ZONES WAS TO ALLOW  
FORECASTERS TO MORE ACCURATELY PORTRAY ONGOING AND PREDICTED WEATHER.  
EACH ZONE WAS NAMED EITHER BY A COUNTY /OR COUNTIES/ OR OTHER RECOGNIZABLE  
GEOGRAPHICAL NAMES.

NO OTHER MONTANA FORECAST ZONES WERE AFFECTED BY THIS CHANGE.

MANY NWS PRODUCTS /NOT JUST ZONE FORECASTS/ WERE AFFECTED BY THIS ZONE  
RECONFIGURATION. THIS IS BECAUSE THE Z FORM OF THE UGC USED IN THESE  
PRODUCTS NOW CONTAINS NEW ZONE NUMBERS TO IDENTIFY SPECIFIC AREAS WITHIN  
THE STATE. TABLE 2 LISTS THE PRODUCT CATEGORIES AFFECTED WITH THEIR NOAA  
WEATHER WIRE SERVICE /NWWS/ AND FAMILY OF SERVICES /FOS/ IDENTIFIERS.  
USERS WHO SELECT INFORMATION FOR SPECIFIC ZONES NEEDED TO USE THE NEW UGCS  
FOR THE RECONFIGURED ZONES.

THESE ZONE CHANGES UPDATE PAGES A-113 AND 114 OF NATIONAL WEATHER SERVICE  
OPERATIONS MANUAL CHAPTER C-11...ZONE AND LOCAL FORECASTS...APPENDIX A
