SUBJECT: EXPANDED CODED CITIES FORECAST AND DIGITAL FORECAST PRODUCTS FROM BALTIMORE/WASHINGTON D.C...EFFECTIVE SEPTEMBER 1 2000

ON FRIDAY SEPTEMBER 1 2000...AT 400 AM EDT...THE NATIONAL WEATHER SERVICE IN BALTIMORE/WASHINGTON WILL OFFICIALLY BEGIN ISSUING AN EXPANDED VERSION OF THE CODED CITIES FORECAST AND A NEW EXPERIMENTAL PRODUCT CALLED THE DIGITAL ZONE FORECAST. THE DIGITAL FORMAT OF THESE PRODUCTS WILL FACILITATE THEIR USE WITH COMPUTERS.

EXPANDED CODED CITIES FORECAST:

THE EXPANDED CODED CITIES FORECAST WILL BE SIMILAR TO THE EXISTING PRODUCT FOR DAYS ONE AND TWO...BUT WILL INCLUDE FORECASTS OUT TO FIVE DAYS. THE WORLD METEOROLOGICAL ORGANIZATION /WMO/ HEADER WILL CONTINUE TO BE FPUS41 KWBC. THE NOAA WEATHER WIRE SERVICE /NWWS/ HEADER WBCCCFWBC WILL ALSO REMAIN UNCHANGED. CUSTOMERS WILL NOT NEED TO MAKE ANY COMMUNICATION CHANGES TO CONTINUE RECEIVING THIS PRODUCT.

THE THIRD LINE IS IDENTICAL TO THE OLD CODED CITIES FORECAST...EXCEPT FOR THE ADDITION OF THREE...FOUR-DIGIT GROUPS...EACH SEPARATED BY A SLANT SYMBOL. EACH FOUR DIGIT GROUP REPRESENTS A SNOWFALL RANGE FOR THE FIRST...SECOND AND THIRD PERIODS RESPECTIVELY. SO FOR EXAMPLE...A CODE OF 0001/0306/0204 REPRESENTS A FORECAST OF 0-1 INCHES OF SNOW IN THE FIRST 12 HOURS...3-6 INCHES IN THE SECOND 12 HOUR PERIOD AND 2-4 INCHES IN THE THIRD 12 HOUR PERIOD.

ON THE FOURTH LINE...ABB IS AN EXAMPLE OF A STRING OF THREE ONE-LETTER WEATHER FORECASTS FOR DAYS THREE...FOUR AND FIVE...FOLLOWED BY THE TEMPERATURE FORECAST FOR THE LAST FIVE PERIODS. THE STRING OF ZEROES AT THE END OF THE LINE WILL EVENTUALLY BE REPLACED WITH PRECIPITATION PROBABILITIES FOR SEVEN PERIODS.

DIGITAL ZONE FORECAST:

THE DIGITAL ZONE FORECAST IS A PRODUCT WHICH DISPLAYS FORECASTED WEATHER PARAMETERS IN 3-HOUR INTERVALS. THIS PROVIDES A MORE DETAILED FORECAST AND ALSO MAKES IT EASIER FOR THE USER TO OBTAIN THE WEATHER PARAMETER/S/OF CHOICE. IT IS ESSENTIALLY A DIGITAL DISPLAY OF THE ZONE FORECAST IN MUCH GREATER DETAIL AND WITH FORECAST PROJECTIONS OUT TO FIVE DAYS. THE NARRATIVE VERSION OF THE ZONE FORECAST WILL STILL BE AVAILABLE. THE WMO HEADER AND NWWS HEADER WILL BE FOUS51 KLWX AND WBCRDFLWX...RESPECTIVELY.
