BY THURSDAY NOVEMBER 15 2001...ALL NATIONAL WEATHER SERVICE
FORECAST OFFICES WILL BEGIN ISSUING A NEW SUITE OF HYDROLOGIC
PRODUCTS. THE NEW PRODUCT SUITE REFLECTS CHANGES REQUESTED BY
LOCAL AND NATIONAL CUSTOMERS. THESE CHANGES INCLUDE A SMALLER
NUMBER OF PRODUCT TYPES...INCLUSION OF NEW INFORMATION...AND
SIMPLIFICATION AND STANDARDIZATION OF PRODUCT INFORMATION. ALL
INFORMATION PROVIDED CURRENTLY IN NWS HYDROLOGIC PRODUCTS WILL BE
AVAILABLE IN THE NEW PRODUCT SUITE. SOME PRODUCT TITLES...
FORMATS...CONTENTS AND GENERAL APPEARANCES HAVE CHANGED.
HYDROLOGIC PRODUCTS WILL CONTINUE TO BE BOTH TEXT AND TABLES OF
DATA WHEN NEEDED.

SPECIFIC PRODUCT CHANGES TO BE IMPLEMENTED INCLUDE:

- FLOOD WATCHES WILL ADDRESS THE POTENTIAL FOR BOTH FLASH AND RIVERINE FLOODING
- FLOOD WATCHES WILL BE UPDATED WITH FLOOD WATCHES
- FLOOD WARNINGS WILL BE UPDATED WITH FLOOD WARNINGS
- FLASH FLOOD WARNINGS WILL BE UPDATED WITH FLASH FLOOD WARNINGS
- FLOOD STATEMENTS WILL PROVIDE SUPPLEMENTAL INFORMATION ON FLOOD WATCHES AND WARNINGS AND ALSO PROVIDE INFORMATION

PREVIOUSLY DELIVERED IN THE URBAN AND SMALL STREAM FLOOD
ADVISORY.

THE UNIVERSAL GEOGRAPHIC CODE /UGC/ SHALL BE USED ALONG WITH
STANDARDIZED MASS NEWS DISSEMINATION /MND/ AND WORLD
METEOROLOGICAL ORGANIZATION /WMO/ HEADINGS AND AWIPS IDENTIFIERS
ON ALL PUBLIC HYDROLOGIC PRODUCTS.
