RECONFIGURATION OF BURLINGTON COUNTY INTO TWO SEPARATE  
FORECAST ZONES...EFFECTIVE JUNE 5 2002

EFFECTIVE WEDNESDAY JUNE 5 2002 AT 1800 COORDINATED UNIVERSAL  
TIME /UTC/...200 PM EDT...THERE WILL BE A REALIGNMENT OF FORECAST  
ZONE BOUNDARIES IN BURLINGTON COUNTY IN SOUTHERN NEW JERSEY. THE  
PHILADELPHIA NWS FORECAST OFFICE WILL DIVIDE BURLINGTON COUNTY  
INTO TWO NWS ZONES...NORTHWESTERN BURLINGTON COUNTY AND  
SOUTHEASTERN BURLINGTON COUNTY...TO HELP IMPROVE FORECAST  
SERVICES. THE BOUNDARY ESTABLISHING THESE TWO ZONES IS  
APPROXIMATED BY A LINE RUNNING FROM ROUTE 534 WHERE IT ENTERS THE  
SOUTHERN BOUNDARY OF BURLINGTON COUNTY...TO ROUTE 206...TO ROUTE  
70 WHERE IT EXITS THE NORTHERN BOUNDARY OF BURLINGTON COUNTY.

THE SOUTHEASTERN BURLINGTON COUNTY ZONE WILL BE ASSIGNED A NEW  
ZONE /Z/ FORM OF THE UNIVERSAL GENERIC CODE /UGC/...NJZ027...AND  
WILL CONTAIN THE FOLLOWING TOWNSHIPS: BASS RIVER...SHAMONG...  
TABERNACLE...WASHINGTON...AND WOODLAND. NORTHWESTERN BURLINGTON  
COUNTY WILL CONTAIN ALL OTHER TOWNSHIPS LOCATED IN THE  
COUNTY...AND WILL KEEP THE ORIGINAL UGC /Z/ CODE OF NJZ019.

THE DIVISION OF BURLINGTON COUNTY INTO TWO SEPARATE FORECAST  
ZONES WILL ENABLE FORECASTERS TO ISSUE FORECASTS WHICH BETTER  
REFLECT THE NATURALLY OCCURRING CLIMATIC DIFFERENCES WHICH EXIST  
ACROSS THE COUNTY.

THERE ARE NO CHANGES TO COMMUNICATION IDENTIFIERS WITH THIS  
REALIGNMENT AND NO ACTION IS REQUIRED FOR CONTINUED RECEIPT OF  
PRODUCTS FROM WFO PHILADELPHIA.

THESE ZONE CHANGES REQUIRE CERTAIN USERS...PRIMARILY CABLE TV  
OUTLETS...TO BE AWARE OF THE CHANGES...AND TO TAKE APPROPRIATE  
ACTIONS TO RECEIVE THE ZONES USING THE Z FORM OF UGCS LISTED IN  
TABLE 1. PRODUCTS AFFECTED BY THIS CHANGE ARE LISTED IN TABLE 2.
