EFFECTIVE TUESDAY...MARCH 25 2003...AT 200 AM EST /100 AM CST/...  
NWS WEATHER FORECAST OFFICES /WFOS/ IN THE CENTRAL U.S. WILL  
COMPLETE TRANSITION TO END-STATE WORLD METEOROLOGICAL  
ORGANIZATION /WMO/ COMMUNICATION HEADERS FOR EIGHT OF THEIR  
PUBLIC WARNING PRODUCTS...SEE TABLE 1.

THE SECOND LINE OF THE PRODUCT HEADER...KNOWN AS THE AWIPS  
IDENTIFIER...WILL ALSO BE CHANGED TO REFLECT MODERN SITE  
LOCATION IDENTIFIERS. FOR EXAMPLE...RAP /RAPID CITY/ WILL  
BECOME UNR...ETC. THIS WILL AFFECT PUBLIC WARNING PRODUCTS  
ISSUED BY OFFICES LISTED IN TABLE 2.
