SUBJECT UPDATED - FORECAST ZONE CHANGES IN EASTERN NEW YORK AND
WESTERN NEW ENGLAND...EFFECTIVE APRIL 30 2003

UPDATED EFFECTIVE DATE - THE EFFECTIVE DATE HAS BEEN CHANGED FROM
MONDAY...MARCH 31 TO WEDNESDAY...APRIL 30 2003. THE UPDATED ZONE
MAP SHAPEFILE CAN NOW BE DOWNLOADED...SEE THE WEBSITE BELOW IN
PARAGRAPH TEN /10/.

EFFECTIVE WEDNESDAY...APRIL 30 2003 AT 1800 COORDINATED UNIVERSAL
TIME /UTC/...100 PM EASTERN STANDARD TIME...SIX NEW FORECAST
ZONES WILL BE CREATED IN EASTERN NEW YORK AND WESTERN NEW
ENGLAND. THESE CHANGES AFFECT PRODUCTS ISSUED BY THE NATIONAL
WEATHER SERVICE FORECAST OFFICE /WFO/ IN ALBANY NEW YORK /ALY/.
REFER TO TABLE 1 FOR NEW ZONE NAMES AND CODES. PRODUCTS
AFFECTED BY THIS CHANGE ARE LISTED IN TABLE 2.

FULTON COUNTY NEW YORK WILL BE SPLIT INTO TWO PORTIONS...
NORTHERN AND SOUTHERN. THE SOUTHERN PART WILL RETAIN THE ZONE
NUMBER NYZ039 CURRENTLY USED FOR THE ENTIRE COUNTY. THE
NORTHERN PORTION WILL RECEIVE THE NEW ZONE DESIGNATION NYZ082.
THE SPLIT WILL SEPARATE THE MOHAWK VALLEY FROM THE HIGHER
TERRAIN OF THE SOUTHERN ADIRONDACKS IN THE NORTHERN HALF OF THE
COUNTY.

THE SOUTHEAST PORTION OF WARREN COUNTY NEW YORK WILL BE SPLIT
OFF. THE NORTHERN PORTION WILL RETAIN THE ZONE NUMBER NYZ042
CURRENTLY USED FOR THE ENTIRE COUNTY. THE SOUTHEAST SEGMENT OF
THE COUNTY WILL RECEIVE THE NEW ZONE DESIGNATION NYZ083. THE
SPLIT WILL BREAK THE UPPER HUDSON VALLEY PORTION OF THE COUNTY
OFF FROM THE HIGH PEAKS OF THE EASTERN ADIRONDACKS IN THE
NORTHERN PART OF THE COUNTY.

WASHINGTON COUNTY NEW YORK WILL BE SPLIT INTO TWO PORTIONS...
NORTHERN AND SOUTHERN. THE NORTHERN HALF OF THE COUNTY WILL
RETAIN THE ZONE NUMBER NYZ043...CURRENTLY USED FOR THE ENTIRE
COUNTY. THE SOUTHERN HALF WILL RECEIVE THE NEW ZONE DESIGNATION
NYZ084. THE SPLIT WILL SEPARATE THE CHAMPLAIN VALLEY PORTION OF

THE NORTHERN HALF OF THE COUNTY FROM THE HIGHER TERRAIN OF THE NORTHERN TACONICS IN THE SOUTHERN PART OF THE COUNTY.

WINDHAM COUNTY VERMONT WILL BE SPLIT INTO TWO PORTIONS...EASTERN AND WESTERN. THE WESTERN PART OF THE COUNTY WILL RETAIN THE ZONE NUMBER VTZ014...CURRENTLY USED FOR THE ENTIRE COUNTY. THE EASTERN PART OF THE COUNTY WILL RECEIVE THE NEW ZONE DESIGNATION VTZ015. THE SPLIT WILL SEPARATE THE CONNECTICUT RIVER VALLEY IN THE EASTERN PART OF THE COUNTY FROM THE GREENE MOUNTAINS IN THE WESTERN PART OF THE COUNTY.

BERKSHIRE COUNTY MASSACHUSETTS WILL BE SPLIT INTO TWO PORTIONS...NORTHERN AND SOUTHERN. THE NORTHERN HALF OF THE COUNTY WILL RETAIN THE ZONE NUMBER MAZ001...CURRENTLY USED FOR THE ENTIRE COUNTY. THE SOUTHERN HALF WILL RECEIVE THE NEW ZONE DESIGNATION MAZ025. THE SPLIT WILL SEPARATE THE HIGHER TERRAIN OF THE NORTHERN PART OF THE COUNTY FROM THE MORE MODEST MOUNTAINS OF THE SOUTHERN BERKSHIRES.

LITCHFIELD COUNTY CONNECTICUT WILL BE SPLIT INTO TWO PORTIONS...NORTHERN AND SOUTHERN. THE NORTHERN HALF OF THE COUNTY WILL RETAIN THE ZONE NUMBER CTZ001...CURRENTLY USED FOR THE ENTIRE COUNTY. THE SOUTHERN HALF WILL RECEIVE THE NEW ZONE DESIGNATION CTZ013. THE SPLIT WILL SEPARATE THE HIGHER TERRAIN OF THE LITCHFIELD HILLS FROM THE BEGINNINGS OF THE COASTAL PLAIN IN THE SOUTHERN PART OF THE COUNTY.

THESE CHANGES WILL ALLOW FORECASTS FOR EASTERN NEW YORK AND WESTERN NEW ENGLAND TO BE MORE AREA SPECIFIC.
