SUBJECT: CHANGE OF ISSUANCE TIME FOR THE DAY 1 AND DAY 2 FINAL  
PROBABILISTIC WINTER WEATHER GUIDANCE GRAPHICS ISSUED BY NCEP  
HYDROMETEOROLOGICAL PREDICTION CENTER /HPC/: EFFECTIVE SEPTEMBER 30 2003

ON TUESDAY...SEPTEMBER 30 2003...THE NATIONAL WEATHER SERVICE WILL CHANGE  
THE ISSUANCE TIME OF THE DAY 1 AND DAY 2 FINAL PROBABILISTIC WINTER  
WEATHER GUIDANCE GRAPHICS. THESE PRODUCTS ARE ISSUED BY THE NATIONAL  
CENTER FOR ENVIRONMENTAL PREDICTION /NCEP/ HYDROMETEOROLOGICAL PREDICTION  
CENTER /HPC/. THE LATER ISSUANCE TIME WILL ALLOW HPC FORECASTERS TO  
EVALUATE ADDITIONAL MODEL DATA AND COLLABORATE AND INCORPORATE INPUT FROM  
FIELD FORECASTERS INTO THE FINAL NATIONAL CENTER PRODUCT. THE NEW  
ISSUANCE TIMES WILL BE NO LATER THAN THE TIMES LISTED IN TABLE 1. TABLE 2  
CONTAINS THE COMMUNICATION IDENTIFIERS FOR THESE PRODUCTS.

THE FINAL PROBABILISTIC WINTER WEATHER GUIDANCE GRAPHICS DEPICT THE  
PROBABILITY OF EXCEEDING SPECIFIC THRESHOLDS OF SNOW AND ICE ACCUMULATIONS  
OVER THE CONTIGUOUS U.S. /CONUS/.
