ORGANIZATION /WMO/ HEADING INFORMATION FOR TERMINAL AERODROME FORECAST
/TAF/ FOR TONOPAH AIRPORT AND CHANGED REFERENCE TO [TECHNICAL
IMPLEMENTATION NOTICE 03-36](#).

EFFECTIVE MONDAY...OCTOBER 20 2003 AT 2000 COORDINATED UNIVERSAL TIME
/UTC/...100 PM PACIFIC DAYLIGHT TIME /PDT/...ONE PUBLIC FORECAST ZONE AND
THE CORRESPONDING PORTION OF THE COUNTY IN CENTRAL NEVADA WILL BE
TRANSFERRED FROM ONE WEATHER FORECAST OFFICE /WFO/ COUNTY WARNING FORECAST
AREA /CWFA/ TO ANOTHER. THE NORTHERN NYE COUNTY ZONE /NVZ013/ ALONG WITH
THE NORTHERN PORTION OF THE COUNTY /NVC023/ WILL BE TRANSFERRED FROM THE
LAS VEGAS NEVADA /VEF/ WFO CWFA TO THE ELKO NEVADA /LKN/ WFO CWFA.

THIS CHANGE WILL AFFECT PRODUCTS ISSUED BY BOTH THE LAS VEGAS AND ELKO
WFOS. PRODUCTS THAT USE THE ZONE FORM OF THE UNIVERSAL GEOGRAPHIC CODE
/UGC/ NVZ013 WILL BE GENERATED BY WFO ELKO. PRODUCTS USING THE COUNTY /C/
FORM OF THE UGC NVC023 WILL BE GENERATED BY BOTH WFO LAS VEGAS AND WFO
ELKO. WFO ELKO WILL HAVE THE WARNING RESPONSIBILITY FOR THE NORTHERN
PORTION OF NYE COUNTY...WHILE WFO LAS VEGAS WILL RETAIN THE WARNING
RESPONSIBILITY FOR THE REMAINDER OF THE COUNTY. REFER TO TABLE 1 FOR THE
PRODUCTS AFFECTED BY THIS CHANGE.

THE ZONE CONFIGURATION WILL REMAIN UNCHANGED AND CONTINUE TO COVER ALL OF
NORTHERN NYE COUNTY. THE ZONE UGC WILL ALSO REMAIN THE SAME...NVZ013.

THIS CHANGE WILL COINCIDE WITH THE CURRENT FIRE WEATHER ZONE CONFIGURATION
FOR THE ELKO OFFICE. IN ADDITION...THE NORTHERN NYE COUNTY PUBLIC ZONE
BETTER FITS THE CLIMATOLOGY AND TERRAIN OF EAST CENTRAL NEVADA FOR WHICH
THE ELKO OFFICE IS CURRENTLY RESPONSIBLE.

ALSO...NOTE THAT ON THE SAME EFFECTIVE DATE...THE RESPONSIBILITY FOR
ISSUING THE TERMINAL AERODROME FORECAST /TAF/ FOR TONOPAH AIRPORT /KTPH/
WILL ALSO BE TRANSFERRED FROM WFO LAS VEGAS TO WFO ELKO. REFER TO
