ON THURSDAY...APRIL 1 2004 AT 400 AM CENTRAL STANDARD TIME /CST/...THE
STATE FORECAST PRODUCT /SFP/ FOR LOUISIANA...ISSUED BY THE NATIONAL
WEATHER SERVICE OFFICE /NWS/ IN NEW ORLEANS...WILL BE CHANGING FROM A
NARRATIVE FORMAT TO A TABULAR FORMAT.

THE TABULAR FORMAT PRODUCT /TABULAR STATE FORECAST/ WILL BE ISSUED BY THE
NATIONAL WEATHER SERVICE /NWS/ OFFICES IN LAKE CHARLES...SHREVEPORT AND
NEW ORLEANS FOR CITIES IN THEIR RESPECTIVE AREAS OF RESPONSIBILITY.
FORECASTS FOR EIGHT LOUISIANA CITIES WILL BE CONTAINED IN THE TABULAR
STATE FORECAST PRODUCTS.

THE FORECAST ELEMENTS IN THE TABULAR STATE FORECAST WILL INCLUDE THE HIGH
AND LOW TEMPERATURE...PREDOMINANT WEATHER AND PROBABILITY OF
PRECIPITATION. THESE FORECASTS WILL PROJECT OUT TO SEVEN DAYS.

ALL CUSTOMERS SHOULD TAKE APPROPRIATE ACTIONS TO RECEIVE THE NEW
PRODUCTS...WHICH ARE LISTED IN TABLE 1. CUSTOMERS CURRENTLY RECEIVING
STATE FORECAST PRODUCT FOR LOUISIANA IN NARRATIVE FORMAT UNDER THE CURRENT
HEADINGS LISTED IN TABLE 1 SHOULD ENSURE THEY HAVE ACCESS TO THE NEW
TABULAR STATE FORECAST HEADINGS SHOWN IN TABLE 1.
