EFFECTIVE TUESDAY MAY 11 2004 AT 1100 A.M. CENTRAL STANDARD TIME
/CST/... 1500 COORDINATED UNIVERSAL TIME /UTC/...HYDROLOGIC
SERVICE RESPONSIBILITY FOR THE TRINITY RIVER AT CROCKETT /CRKT2/
IN TEXAS WILL BE TRANSFERRED TO THE WEATHER FORECAST OFFICE /WFO/
IN HOUSTON/GALVESTON /WFO HGX/ FROM THE WFO IN FORT WORTH /WFO
FWD/. THESE CHANGES WILL ENABLE MORE EFFICIENT SERVICE IN THIS
HYDROLOGIC AREA. SEE TABLE 1 FOR THE DETAILS ON THE RIVER
FORECAST POINT.
