ON TUESDAY...MAY 18 2004 AT APPROXIMATELY 1800 COORDINATED UNIVERSAL TIME /UTC/...THE NATIONAL WEATHER SERVICE /NWS/...AT THE REQUEST OF THE ENVIRONMENTAL PROTECTION AGENCY /EPA/...WILL MAKE MINOR CHANGES TO THE ULTRAVIOLET INDEX /UVI/ PRODUCT. THESE CHANGES WILL RESULT IN SLIGHTLY REVISED UVI EXPOSURE CATEGORIES CONSISTENT WITH THE EXPOSURE CATEGORIES ESTABLISHED BY THE WORLD HEALTH ORGANIZATION /WHO/. NOTE: THE SCIENCE BEHIND THE UVI AND THE FORECAST VALUES ARE NOT CHANGING.
