CONVECTIVE WATCH PRODUCTS AFTER FEBRUARY 22 2005. THE STORM
PREDICTION CENTER /SPC/ AND THE NORMAN OK WEATHER FORECAST OFFICE
/WFO/ WILL HOST A WATCH BY COUNTY AND VALID TIME EVENT CODE
TECHNICAL WORKSHOP ON DECEMBER 8 2004 IN NORMAN OK TO BRIEF USERS
ON RECENT DECISIONS AND AMENDED SERVICE CHANGE NOTICES.

ON TUESDAY...FEBRUARY 22 2005 AT 1200 COORDINATED UNIVERSAL
TIME /UTC/... THE STORM PREDICTION CENTER /SPC/ WILL DISCONTINUE
PUBLIC WATCH COUNTY LISTS /SEV/ TO DEPICT ALL COUNTIES AND
INDEPENDENT CITIES IN INITIAL SEVERE THUNDERSTORM AND TORNADO
WATCH AREAS.

ON TUESDAY...FEBRUARY 22 2005 AT 1200 UTC... DESIGNATED WFO/S IN
THE CONTIGUOUS UNITED STATES WILL DISCONTINUE ISSUING STATE AREAL
OUTLINE STATEMENTS /SLS/ TO DEPICT COUNTIES AND INDEPENDENT CITIES
IN INITIAL SEVERE THUNDERSTORM AND TORNADO WATCH AREAS FOR THEIR
STATE OR STATES.

THE INFORMATION THAT WAS CONTAINED IN THE SEV AND SLS PRODUCTS CAN
NOW BE FOUND IN THE WATCH OUTLINE UPDATE MESSAGE /WOU/ ISSUED BY
THE SPC.

ALL WFO/S IN THE CONTIGUOUS UNITED STATES WILL CONTINUE TO ISSUE
SPECIAL WEATHER STATEMENTS /SPS/ TO CANCEL COUNTIES...INDEPENDENT
CITIES AND NEARSHORE MARINE ZONES FROM SEVERE THUNDERSTORM AND
TORNADO WATCH AREAS.
