WATERS IN ALASKA: EFFECTIVE JUNE 1 2005 AT 0000 UTC

ON WEDNESDAY...JUNE 1 2005...AT 0000 COORDINATED UNIVERSAL TIME
/UTC/...THE NATIONAL WEATHER SERVICE /NWS/ WEATHER FORECAST OFFICE /WFO/
IN FAIRBANKS ALASKA WILL IMPLEMENT NEW MARINE ZONES TO ITS GEOGRAPHIC AREA
OF RESPONSIBILITY. THE NEW ZONES ARE LISTED IN TABLE 2.

ALSO...THE NORTHERN ALASKA COASTAL WATERS FORECAST /CWF/ PRODUCT AND
ASSOCIATED NAVIGATIONAL TELEX /NAVTEX/ PRODUCT WILL BE MODIFIED. AS THE
NEW MARINE ZONES ARE IMPLEMENTED...THEY WILL BE DIVIDED INTO TWO PRODUCT
SETS: ONE FOR THE ARCTIC COASTAL WATERS AND THE OTHER FOR THE WESTERN
ALASKA COASTAL WATERS. THE WORLD METEOROLOGICAL ORGANIZATION /WMO/
HEADINGS AND ADVANCED WEATHER INTERACTIVE PROCESSING SYSTEM /AWIPS/ IDS
FOR THESE TEXT PRODUCTS ARE SHOWN IN TABLE 1. PRODUCTS AFFECTED BY THESE
CHANGES ARE LISTED IN TABLE 3.

FAILURE TO DO SO WILL PREVENT THESE PRODUCTS FROM REACHING THEIR INTENDED AUDIENCE.

NWS CUSTOMERS WHO AUTOMATICALLY PROCESS PRODUCTS LISTED IN TABLE 3 USING THE Z FORM OF THE UGC MAY NEED TO PROGRAM THE NEW Z CODES INTO THEIR SYSTEM/S/ NO LATER THAN JUNE 1 2005 TO CONTINUE TO PROCESS THE PRODUCTS.

A WEBPAGE HAS BEEN ESTABLISHED TO ALLOW USERS TO TEST THE CHANGES TO ENSURE THEY CAN DECODE THE MODIFIED PRODUCT CORRECTLY. SEE EXAMPLES AT /USE LOWER CASE/:
