EFFECTIVE THURSDAY...OCTOBER 20 2005 AT 500 AM PACIFIC DAYLIGHT TIME /PDT/...1200 COORDINATED UNIVERSAL TIME /UTC/...THE NWS SAN FRANCISCO BAY AREA /MTR/ WEATHER FORECAST OFFICE /WFO/ WILL RECONFIGURE ITS CURRENT PUBLIC FORECAST ZONE NAMES AND NUMBERS FOR THE GREATER SAN FRANCISCO AND MONTEREY BAY REGIONS OF CALIFORNIA LISTED IN TABLE 1.

ALL WFO MTR PUBLIC FORECAST ZONE NAMES AND NUMBERS WILL CHANGE EXCEPT CAZ006 /SAN FRANCISCO/. CAZ006 /SAN FRANCISCO/ REMAINS THE SAME IN THE RECONGIGURED ZONE SCHEME.

THE CATEGORIES OF AFFECTED PRODUCTS THAT USE THE Z FORM OF THE UGC ARE LISTED IN TABLE 3 WITH THEIR NOAA WEATHER WIRE SERVICE /NWWS/ AND FAMILY OF SERVICES /FOS/ IDENTIFIERS.
