EFFECTIVE WEDNESDAY NOVEMBER 30 2005 AT 1100 A.M. CENTRAL STANDARD TIME
/CST/...1500 COORDINATED UNIVERSAL TIME /UTC/...HYDROLOGIC SERVICE
RESPONSIBILITY FOR CLAY...LOWNDES AND NOXUBEE COUNTIES IN MISSISSIPPI WILL
BE TRANSFERRED TO THE WEATHER FORECAST OFFICE /WFO/ IN JACKSON /WFO JAN/
FROM THE WFO IN MEMPHIS /WFO MEG/. THESE CHANGES WILL ENABLE MORE
EFFICIENT SERVICE IN THIS HYDROLOGIC AREA. SEE TABLE 1 FOR DETAILS ON THE
RIVER FORECAST POINTS TO BE TRANSFERRED TO WFO JACKSON FROM WFO MEMPHIS ON
NOVEMBER 30 2005.

SHORTENED LEAD TIME IS BEING PROVIDED FOR THIS SERVICE CHANGE NOTICE
BECAUSE DURING AN INTER-AGENCY MEETING...THE COLUMBUS...LOWNDES...NOXUBEE
AND CLAY COUNTY EMERGENCY MANAGEMENT DIVISIONS REQUESTED THE CHANGE OCCUR
ON NOVEMBER 30 2005 TO COINCIDE WITH THE END OF THE HURRICANE SEASON.

BECAUSE OF THIS TRANSFER...CUSTOMERS MUST TAKE APPROPRIATE ACTION TO
RECEIVE THE PRODUCTS LISTED IN TABLE 2 FOR CLAY...LOWNDES AND NOXUBEE
COUNTIES IN MISSISSIPPI USING THE JAN IDENTIFIER.
