SUBJECT: RECONFIGURATION OF PUBLIC FORECAST ZONES AND ZONE NUMBERS FOR
WESTERN WASHINGTON: EFFECTIVE FEBRUARY 28 2006

EFFECTIVE TUESDAY...FEBRUARY 28 2006 AT 400 A.M. PACIFIC STANDARD TIME
/PST/...1200 COORDINATED UNIVERSAL TIME /UTC/...THE NWS WEATHER FORECAST
OFFICE /WFO/ IN SEATTLE WA /SEW/ WILL INSTITUTE A RECONFIGURATION OF ITS
CURRENT PUBLIC FORECAST ZONES IN ITS AREA OF RESPONSIBILITY FOR WESTERN
WASHINGTON.

THIS RECONFIGURATION WILL HELP PROVIDE BETTER SITE-SPECIFIC FORECASTS BY
AFFORDING FORECASTERS THE NEEDED FLEXIBILITY TO SEPARATE AND HIGHLIGHT
SMALLER ZONES BASED ON CLIMATOLOGY...TOPOGRAPHY AND MEDIA SERVICE AREAS TO
MORE ACCURATELY REFLECT ONGOING AND PREDICTED WEATHER.

ALL OF THE CURRENT WESTERN WASHINGTON ZONES WILL BE REFIGURED AND
RENUMBERED EXCEPT ZONE NUMBER 1 /WAZ001 - SAN JUAN/. THE CURRENT ZONES
ARE LISTED IN TABLE 1. THE NEW WESTERN WASHINGTON ZONES ARE AS LISTED IN
TABLE 2.

MANY NWS PRODUCTS /NOT JUST ZONE FORECASTS/ WILL BE AFFECTED BY THE ZONE
RECONFIGURATIONS. THIS IS BECAUSE THE Z FORM OF THE UNIVERSAL GEOGRAPHIC
CODE /UGC/ USED IN THESE PRODUCTS WILL CONTAIN THE RECONFIGURED ZONES AND
NEW ZONE NUMBERS TO FURTHER IDENTIFY SPECIFIC AREAS BY ZONE WITHIN THE
STATE. CATEGORIES OF AFFECTED PRODUCTS THAT USE THE Z FORM OF THE UGC ARE
LISTED IN TABLE 3.

NWS CUSTOMERS WILL NEED TO MAKE CHANGES TO PROPERLY RECEIVE WFO SEATTLE
PUBLIC FORECAST AND WARNING PRODUCTS FOR THE RECONFIGURED ZONES.

- IN [SERVICE CHANGE NOTICE /SCN/ 05-29](#)...ISSUED JULY 22 2005 AND EFFECTIVE NOVEMBER 15 2005...WASHINGTON ZONE NUMBERS WAZ501 AND WAZ502 ARE ALREADY ASSIGNED TO WFO PENDLETON OREGON AREA OF RESPONSIBILITY. THEREFORE...THE SEATTLE ZONES RENUMBERING WILL START WITH WAZ503.

- SINCE THERE WILL BE NO CHANGE TO THE CURRENT SEATTLE ZONE NUMBER WAZ001...IT WILL NOT BE RENUMBERED. IT WILL REMAIN THE SAME TO MAINTAIN THE CLIMATOLOGICAL DATABASE.
