TIME /UTC/ OR WEDNESDAY FEBRUARY 14 2007 AT 0600 AM GUAM LOCAL
STANDARD TIME /LST/...CHANGES WILL BE MADE TO THE ISSUANCE AND
CONTENT OF THE SURF ZONE FORECAST /SRF/ AND THE ISSUANCE OF THE

PRODUCT EFFECTIVE FEBRUARY 14 2007 AT 0600 AM GUAM LST.

THE CURRENT SRF PRODUCT IS ISSUED ONCE PER DAY AT 0600 AM GUAM
LST...2000 UTC.

THE NEW SRF PRODUCT WILL BE ISSUED TWICE PER DAY AT:
0600 AM GUAM LST...2000 UTC.
0600 PM GUAM LST...0800 UTC.

THE FOLLOWING PARAMETERS WILL BE REMOVED FROM THE NEW SRF
PRODUCT:

LIGHTNING RISK

CLIMATE DATA IS AVAILABLE DAILY AT AWIPS HEADER CLIGUM...AND WMO HEADER CDGM40 PGUM.

THE FOLLOWING FORECAST PARAMETERS WILL BE ADDED TO THE NEW SRF:

- PRIMARY/SECONDARY SWELL
- PRIMARY/SECONDARY WAVE PERIOD
- WIND
- HEAT INDEX
- TIDE DATA FOR SAIPAN AND TINIAN

THE FOLLOWING HEADLINES WILL BE ADDED TO THE NEW SRF PRODUCT WHEN REQUIRED:

- HIGH RISK OF RIP CURRENTS
- HIGH SURF ADVISORY

HEADLINES WILL REFERENCE THE AFFECTED REEFS TO FOUR DIRECTIONAL POINTS...NORTH...EAST...SOUTH...AND WEST. HEADLINES WILL INCLUDE A TIME DESCRIPTOR.

THERE ARE NO CHANGES TO THE AWIPS AND WMO PRODUCT HEADERS FOR THE SRF...WHICH WILL CONTINUE TO USE AWIPS ID SRFMY...AND WMO HEADER FZMY50 PGUM.

0600 PM LST...0800 UTC
