EFFECTIVE MAY 15 2007...THE WHXX01 MESSAGE ISSUED BY THE TROPICAL  
PREDICTION CENTER/NATIONAL HURRICANE CENTER /TPC/NHC/ AND THE CENTRAL  
PACIFIC HURRICANE CENTER /CPHC/ WILL HAVE THE FOLLOWING CHANGES:

1. THE ISSUING OFFICE AND DATE/TIME LINE WILL BE ADDED TO THE MASS NEWS  
DISSEMINATOR /MND/ HEADER BLOCK.

FOR THE ATLANTIC AND EAST PACIFIC BASINS...THE MND HEADER BLOCK WILL BE:

1444 UTC WED JAN 10 2007

2. THE SHALLOW BETA ADVECTION MODEL /BAMS/ WILL BE ADDED.

3. THE STATISTICAL TRACK MODELS /A98E/ AND /P91E/ WILL BE DISCONTINUED.

4. THE PRODUCT WILL BE LEFT JUSTIFIED.
