IN ADDITION...EFFECTIVE TUESDAY APRIL 17 2007 AT 1800 UTC...1100 AM PDT...WFO LOS ANGELES/OXNARD /LOX/ WILL CORRECT ITS FIRE WEATHER ZONES AS THEY PERTAIN TO SEVERAL NEAR SHORE ISLANDS (EXCEPT FOR SANTA CATALINA ISLAND WHICH WILL REMAIN IN ZONE CAZ287) TO CORRESPOND WITH ITS PUBLIC FORECAST ZONES. SPECIFICALLY:

- CAZ239 WILL NO LONGER INCLUDE SANTA ROSA...SANTA CRUZ...SAN MIGUEL AND SANTA BARBARA ISLANDS.

- CAZ240 WILL NO LONGER INCLUDE SAN NICHOLAS AND ANACAPA ISLANDS.

- CAZ241 WILL NO LONGER INCLUDE SAN CLEMENTE ISLAND.

WFO LOX DOES NOT HAVE EITHER FIRE WEATHER OR PUBLIC WEATHER FORECAST RESPONSIBILITY FOR THESE ISLANDS.
