EFFECTIVE JUNE 5 2007 AT 1200 COORDINATED UNIVERSAL TIME /UTC/...ALL NWS WEATHER FORECAST OFFICES /WFOS/ WILL BE INCLUDING EXPERIMENTAL VTEC IN THEIR FLOOD PRODUCTS FOR FORECAST POINTS. THE AFFECTED FLOOD PRODUCTS ARE THE FOLLOWING:

FLOOD WARNING FOR FORECAST POINTS /FLW/ FLOOD STATEMENT - FOLLOW UP TO FLOOD WARNING FOR FORECAST POINTS /FLS/ FLOOD ADVISORY FOR FORECAST POINTS /FLS/ FLOOD WATCH FOR FORECAST POINTS /FFA/

AS CITED IN <u>SCN 06-10</u>...NUMEROUS WFOS HAVE ALREADY BEEN ISSUING THESE PRODUCTS WITH EXPERIMENTAL HYDROLOGIC VTEC SINCE APRIL 2006 AS PART OF A RISK REDUCTION ACTIVITY. BY THE END OF THIS RISK REDUCTION ACTIVITY...40 WFOS WERE INCLUDING EXPERIMENTAL VTEC IN THEIR FLOOD PRODUCTS FOR FORECAST POINTS AND CONTINUE TO DO SO. ON JUNE 5 2007...ALL 122 WFOS WILL BE INCLUDING EXPERIMENTAL VTEC IN THEIR FLOOD PRODUCTS FOR FORECAST POINTS. THIS MEANS 82 ADDITIONAL WFOS WILL START INCLUDING EXPERIMENTAL VTEC IN THESE PRODUCTS ON THAT DATE. NOTE: EXPERIMENTAL VTEC FOLLOWS ALL VTEC STANDARDS...BUT USES THE EXPERIMENTAL /X/ PRODUCT CLASS CODE.

ON TUESDAY JULY 17 2007...VTEC WILL BECOME OFFICIALLY OPERATIONAL IN FLOOD PRODUCTS FOR FORECAST POINTS FROM ALL 122 WFOS. THE ONLY CHANGE TAKING PLACE ON THIS DATE WILL BE A SWITCH FROM USING THE EXPERIMENTAL /X/ PRODUCT CLASS CODE TO THE OPERATIONAL /O/ PRODUCT CLASS CODE. THESE DATES FOR NATIONAL IMPLEMENTATION OF VTEC IN FLOOD PRODUCTS FOR FORECAST POINTS ARE SIGNIFICANTLY LATER THAN THE FALL 2006 DATE ANNOUNCED IN <u>SCN 06-23</u>. MORE TIME WAS NEEDED TO ENSURE VTEC WAS READY FOR THESE PRODUCTS.
