EFFECTIVE WEDNESDAY JUNE 27 2007 AT 1800 COORDINATED UNIVERSAL
TIME /UTC/...1400 EASTERN DAYLIGHT TIME /EDT/...OR 1400 ATLANTIC
STANDARD TIME /AST/...AN INTERIM TSUNAMI WARNING PLAN FOR THE
FOLLOWING NATIONS OF THE CARIBBEAN WILL BE IMPLEMENTED UNTIL
SUCH TIME AS THIS CAPABILITY CAN BE MANAGED INDEPENDENTLY WITHIN
THE REGION. THE NATIONS ARE THOSE OF THE INTERGOVERNMENTAL
OCEANOGRAPHIC COMMISSION /IOC/ OF THE UNITED NATIONS
EDUCATIONAL...SCIENTIFIC AND CULTURAL ORGANIZATION /UNESCO/ SUB-
COMMISSION FOR THE CARIBBEAN AND ADJACENT REGIONS /IOCARIBE/.

EFFECTIVE JUNE 27 2007...THE PACIFIC TSUNAMI WARNING CENTER
/PTWC/ WILL IMPLEMENT A SUITE OF TWO TSUNAMI PRODUCTS FOR THE
CARIBBEAN.

THE TSUNAMI MESSAGE PROVIDES WATCH INFORMATION ABOUT A POTENTIAL TSUNAMI INCLUDING ITS SOURCE AND THE ESTIMATED TIME OF ARRIVAL OF INITIAL WAVES AT LOCATIONS INCLUDED IN THE WATCH AREA. IT WILL INCLUDE AN EVALUATION OF THE POTENTIAL FOR TSUNAMI IMPACT. IT IS NOT AUTHORITATIVE BUT IS INTENDED AS ADVICE TO DESIGNATED GOVERNMENT AGENCIES IN EACH COUNTRY.

THE TSUNAMI INFORMATION STATEMENT WILL CONTAIN INFORMATION ABOUT SIGNIFICANT EARTHQUAKES WHICH ARE NOT LIKELY TO TRIGGER A TSUNAMI. IT IS NOT AUTHORITATIVE BUT IS INTENDED AS ADVICE TO DESIGNATED GOVERNMENT AGENCIES IN EACH COUNTRY.

THE COMMUNICATIONS HEADINGS AND IDENTIFIERS FOR THESE PRODUCTS ARE LISTED IN TABLE 1. IMPORTANT NOTE: USERS OF NWS PRODUCTS MUST UPDATE THEIR COMMUNICATION SYSTEM DIRECTORIES TO RECEIVE THESE PRODUCTS.
