ON TUESDAY AUGUST 5 2008 AT 1800 COORDINATED UNIVERSAL TIME /UTC/...NWS
FORECAST OFFICES /WFOS/ SERVING THE ATLANTIC...PACIFIC...GULF AND GREAT
LAKES COASTS WILL BEGIN ISSUING THE OPERATIONAL MARINE WEATHER MESSAGE /MWW/
PRODUCT. THIS PRODUCT IS INTENDED TO BETTER INFORM MARINERS OF MARINE
WEATHER HAZARDS AND SERVE AS A DEDICATED LONG DURATION MARINE
WATCH/WARNING/ADVISORY PRODUCT.

THE MWW WILL IMPLEMENT THE OPERATIONAL VALID TIME EVENT CODE /VTEC/ FOR ALL
LONG TERM MARINE WATCH/WARNING/ADVISORY EVENTS. THIS INCLUDES THE
IMPLEMENTATION OF FIVE NEW MARINE WATCH PRODUCTS USING FIVE NEW VTEC
PHENOMENA AND SIGNIFICANCE CODE PAIRINGS.
