OF SOUTHERN CALIFORNIA FROM LOS ANGELES TO THE UNITED STATES/MEXICO

THE TCV IS ISSUED BY THE NATIONAL HURRICANE CENTER. IT SUMMARIZES ALL  
NEW...CONTINUED AND CANCELED TROPICAL CYCLONE WATCHES AND WARNINGS. THE  
TCV IS ISSUED AT APPROXIMATELY 03...09...15 AND 21 COORDINATED UNIVERSAL  
TIME /UTC/ FOR SPECIAL ADVISORIES IF WATCHES OR WARNINGS ARE  
POSTED...CHANGED OR CANCELED...AND FOR IMMEDIATE ADVISORIES IF WATCHES OR  
WARNINGS ARE CANCELED. A DESCRIPTION OF THE PRODUCT AND AN EXAMPLE OF THE
