SUBJECT: AMENDED: CHANGES TO THE BOUNDARIES OF SOME OF THE FIRE  
AND PUBLIC WEATHER ZONES IN LOS ANGELES COUNTY CA:  
EFFECTIVE SEPTEMBER 16 2008

EFFECTIVE TUESDAY SEPT 16 2008 AT 1200 COORDINATED UNIVERSAL TIME  
/UTC/...THE NWS WEATHER FORECAST OFFICE /WFO/ IN OXNARD CA /LOX/  
WILL SPLIT THE LOS ANGELES COUNTY VALLEYS ZONE CURRENTLY USED FOR  
FIRE AND PUBLIC WEATHER PRODUCTS AND SERVICES INTO TWO NEW ZONES.  
THE ORIGINAL EFFECTIVE DATE WAS POSTPONED DUE TO CRITICAL WEATHER  
DAY RESTRICTIONS ON SEPTEMBER 9. NO OTHER CHANGES WERE MADE TO  
THIS NOTICE.

IN ADDITION MINOR CHANGES WILL BE MADE TO THE LOS ANGELES COUNTY  
COASTAL ZONE AND THE SANTA MONICA MOUNTAINS RECREATIONAL ZONE.  
THE PURPOSE OF THESE CHANGES IS TO IMPROVE SERVICES FOR WFO LOX  
FIRE AND PUBLIC WEATHER PARTNERS AND USERS BY BETTER ASSOCIATING  
ZONE AREAS WITH WEATHER REGIMES.

THE SPLIT OF THE LOS ANGELES COUNTY VALLEYS ZONE /CURRENTLY FIRE  
ZONE CAZ247/PUBLIC ZONE CAZ047/ WILL SEPARATE THE SAN GABRIEL AND  
SAN FERNANDO VALLEYS INTO TWO NEW ZONES /FIRE AND PUBLIC ZONES  
CAZ547 AND FIRE AND PUBLIC ZONES CAZ548/. THE SPLIT WILL BE  
ALONG A NORTH-SOUTH LINE FROM NEAR GRIFFITH PARK AT I-5  
...EXTENDING NORTH TO THE SAN RAFAEL HILLS TO THE ANGELES  
NATIONAL FOREST. SINCE THE NEW FIRE ZONES AND PUBLIC ZONES WILL  
BE IDENTICAL IN ZONE NAME AND ZONE GEOGRAPHY...THE SAME ZONE  
NUMBERS WILL BE USED FOR EACH CORRESPONDING FIRE/PUBLIC ZONE.  
FOR EXAMPLE CA FIRE ZONE 547 AND CA PUBLIC ZONE 547 WILL BE  
IDENTICAL IN ZONE NAME...NUMBER...AND GEOGRAPHY.

ONCE THIS CHANGE HAS BEEN IMPLEMENTED...LOX WILL USE THE  
FOLLOWING GEOGRAPHICAL DESCRIPTORS IN ALL ITS FIRE AND PUBLIC  
WEATHER FORECAST PRODUCTS:

FIRE CAZ547/PUBLIC CAZ547        LOS ANGELES COUNTY SAN

## FERNANDO VALLEY

PHYSICAL DESCRIPTION: REPRESENTS THE SAN FERNANDO VALLEY OF LOS ANGELES COUNTY. THIS ZONE EXTENDS FROM THE COUNTY LINE ON THE WEST...ON THE NORTH BY THE 2000 FOOT TERRAIN CONTOUR...ON THE SOUTH BY THE 1500 FOOT TERRAIN CONTOUR BETWEEN THE VENTURA COUNTY LINE AND I-405 AND EASTWARD ALONG MULHOLLAND DRIVE TO THE 101 FREEWAY THEN CONTINUING SOUTHEAST TO HIGHWAY 2...THEN NORTH TO HIGHWAY 134...CONTINUING EAST ON HIGHWAY 134 TO JUST WEST OF EAGLE ROCK...THEN NORTHWARD ALONG THE RIDGELINE OF THE SAN RAFAEL HILLS TO NEAR THE JET PROPULSION LABORATORY AT THE BASE OF THE ANGELES NATIONAL FOREST.

FIRE CAZ548/PUBLIC CAZ548      LOS ANGELES COUNTY SAN  
GABRIEL VALLEY

PHYSICAL DESCRIPTION: REPRESENTS THE SAN GABRIEL VALLEY OF LOS ANGELES COUNTY. THIS ZONE IS DEFINED ON THE NORTH BY THE 2000 FOOT TERRAIN CONTOUR...ON THE WEST BY A NORTH-SOUTH LINE FOLLOWING THE RIDGELINE OF THE SAN RAFAEL HILLS FROM NEAR THE JET PROPULSION LABORATORY TO HIGHWAY 134 NEAR EAGLE ROCK...CONTINUING WEST ACROSS HIGHWAY 134 TO HIGHWAY 2...FOLLOWING HIGHWAY 2 SOUTH TO HIGHWAY 101...CONTINUING AROUND THE PERIMETER OF ELYSIAN PARK TO I-5...ON THE SOUTH ALONG I-5...AND ON THE EAST BY THE COUNTY LINE.

FIRE CAZ241/PUBLIC CAZ041      LOS ANGELES COUNTY COAST  
INCLUDING DOWNTOWN LOS  
ANGELES

PHYSICAL DESCRIPTION: REPRESENTS THE LOS ANGELES COUNTY COASTAL AREA. DEFINED ON THE WEST BY THE VENTURA COUNTY LINE THEN EAST ALONG THE 500 FOOT TERRAIN CONTOUR TO I-405...THEN NORTH TO MULHOLLAND DRIVE CONTINUING EASTWARD TO THE 101 FREEWAY...THEN SOUTHEAST TO HIGHWAY 2...CONTINUING WEST AND SOUTH AROUND THE PERIMETER OF ELYSIAN PARK TO THE 110 FREEWAY...THEN NORTHEAST TO I-5...CONTINUING SOUTH FOLLOWING I-5 TO THE COUNTY LINE...ON THE SOUTH BY THE COUNTY LINE...ON THE SOUTH AND WEST BY THE COAST.

FIRE CAZ246/PUBLIC CAZ046      SANTA MONICA MOUNTAINS  
RECREATIONAL AREA

PHYSICAL DESCRIPTION: REPRESENTS THE SANTA MONICA MOUNTAINS RECREATIONAL AREA. DEFINED ON THE NORTH BY THE 1500 FOOT TERRAIN CONTOUR...ON THE WEST BY THE COUNTY LINE...ON THE SOUTH BY THE 500 FOOT TERRAIN CONTOUR...ON THE EAST BY I-405.
