EFFECTIVE WEDNESDAY JUNE 25 2008 AT 0001 COORDINATED UNIVERSAL TIME /UTC/...WFO FLAGSTAFF AZ /FGZ/ WILL REALIGN ITS FIRE WEATHER ZONE BOUNDARIES /AZZ104 - AZZ118 AND AZZ137 - AZZ140/ TO MATCH ITS PUBLIC WEATHER ZONE BOUNDARIES /AZZ004 - AZZ018 AND AZZ037 - AZZ040/. WFO FGZ FIRE ZONES WILL BECOME IDENTICAL TO ITS CORRESPONDING PUBLIC ZONES IN GEOGRAPHY WHILE RETAINING THEIR CURRENT FIRE WEATHER ZONE NUMBERS AND NAMES.

THESE MINOR FIRE WEATHER ZONE BOUNDARY ADJUSTMENTS ARE BEING MADE TO BRING FGZ FIRE WEATHER ZONES INTO EXACT ALIGNMENT WITH THEIR PREVIOUSLY ADJUSTED CORRESPONDING PUBLIC ZONES.

NWS PARTNERS AND USERS NEED TO BE AWARE OF THESE CHANGES AND TAKE APPROPRIATE ACTION.
