/MOB/ WILL REVISE ITS POINT FORECAST MATRICES PRODUCT /PFM/ TO
INCLUDE THE NEW LOCATIONS OF GREENVILLE ALABAMA AND CRESTVIEW
FLORIDA. IN ADDITION CITY LOCATIONS OF WAYNESBORO MISSISSIPPI
...CAMDEN ALABAMA...AND DESTIN FLORIDA WILL BE REMOVED FROM THE
PRODUCT.

POINT AND CLICK FORECAST AT /USE LOWERCASE/:

ONCE AT THE WEBSITE...CLICK ON THE GEOGRAPHIC REGION WHERE YOU
DESIRE A FORECAST AND THEN SELECT TABULAR FORECAST IN THE LOWER
RIGHT PORTION OF THE PAGE. THE TABULAR FORECAST IS NEARLY
IDENTICAL TO THE PFM.
