THE CHANGES HAVE BEEN MADE IN RESPONSE TO USER COMMENTS ABOUT THE LENGTH OF THE PRODUCT. THE CHANGES WILL RESULT IN A SHORTER OVERALL PRODUCT...WITH STANDARDIZED SECTION HEADERS PROVIDED IN AN OPTIONAL OVERVIEW BLOCK AND IN THE VTEC SEGMENTS.
