THE EFFECTIVE DATE OF THIS CHANGE IS DELAYED UNTIL MONDAY OCTOBER
5 2009 AT 200 PM MOUNTAIN DAYLIGHT TIME /MDT/...2000 COORDINATED
UNIVERSAL TIME /UTC/...DUE TO ONGOING WEATHER IN WFO RIVERTON WY
AREA OF FORECAST RESPONSIBILITY.

OTHER CHANGES.

EFFECTIVE THURSDAY OCTOBER 1 2009 AT 200 PM MOUNTAIN DAYLIGHT TIME
/MDT/...2000 COORDINATED UNIVERSAL TIME /UTC/... THE NWS FORECAST
OFFICE /WFO/ IN RIVERTON WYOMING /RIW/ WILL RECONFIGURE SIX PUBLIC
FORECAST ZONE BOUNDARIES IN WESTERN AND CENTRAL WYOMING.

THE MAIN PURPOSE OF THESE CHANGES IS TO PROPERLY ALIGN WFO RIW
PUBLIC FORECAST ZONES WITH THOSE OF WFO CHEYENNE WYOMING /CYS/. A

POINTS AND DO NOT SIGNIFICANTLY AFFECT THE CLIMATOLOGY OF THE
RECONFIGURED PUBLIC FORECAST ZONES.

THERE ARE NO CHANGES TO WORLD METEOROLOGICAL ORGANIZATION HEADINGS
OR ADVANCED WEATHER INTERACTIVE PROCESSING SYSTEM IDENTIFIERS WITH
THESE CHANGES. NO ACTION IS REQUIRED FOR CONTINUED RECEIPT OF
PRODUCTS FROM RIW.
