FOR THE FLORIDA PANHANDLE AND BIG BEND COUNTIES OF THE TALLAHASSEE FLORIDA  
WEATHER FORECAST OFFICE: EFFECTIVE APRIL 1 2010

EFFECTIVE THURSDAY...APRIL 1 2010 AT 0400 EASTERN DAYLIGHT TIME  
/EDT/...0800 COORDINATED UNIVERSAL TIME /UTC/...SEVERAL FIRE AND PUBLIC  
WEATHER FORECAST ZONES WITHIN THE NWS TALLAHASSEE FLORIDA /TAE/ WEATHER  
FORECAST OFFICE /WFO/ AREA OF RESPONSIBILITY WILL BE CHANGED TO BETTER  
ACCOUNT FOR CLIMATOLOGY AND GEOGRAPHY.

INLAND WALTON /FLZ007/ BECOMES NORTH WALTON /FLZ007/. THIS IS A NAME  
CHANGE ONLY. NO CHANGE IS BEING MADE TO THE GEOGRAPHIC EXTENTS OF THE  
ZONE.

THE REMAINING CHANGES SPLIT COASTAL PORTIONS OF COUNTIES OUT INTO SEPARATE  
ZONES BASED UPON CLIMATOLOGY. THESE NEW COASTAL ZONES ARE ASSIGNED NEW  
ZONE NAMES AND NUMBERS. THE REMAINING NON-COASTAL PORTIONS OF COUNTIES  
RETAIN THEIR CLIMATOLOGY AND THEIR ZONE NUMBERS BUT ARE RENAMED TO BETTER  
IDENTIFY THEIR GEOGRAPHIC EXTENTS.

THE SHORTER ADVANCE LEAD TIME WAS NECESSITATED BY SOFTWARE ISSUES PREPARING THE SHAPEFILES AND WAS APPROVED BECAUSE CURRENT USERS SHOULD NOT HAVE TO MAKE SIGNIFICANT ADJUSTMENTS TO ACCOMMODATE THE CHANGE.
