EFFECTIVE MONDAY...NOVEMBER 15 2010 AT 100 PM EASTERN STANDARD TIME /EST/...1800 COORDINATED UNIVERSAL TIME /UTC/...THE NWS BALTIMORE/WASHINGTON WEATHER FORECAST OFFICE /WFO LWX/ WILL SPLIT TWO FIRE AND PUBLIC FORECAST ZONES INTO FOUR NEW ZONES.

HIGHLAND VIRGINIA...CURRENTLY ZONE VAZO21...WILL SPLIT INTO WESTERN HIGHLAND /VAZ503/ AND EASTERN HIGHLAND /VAZ504/.

PENDLETON WEST VIRGINIA...CURRENTLY ZONE WVZ054...WILL SPLIT INTO WESTERN PENDLETON /WVZ505/ AND EASTERN PENDLETON /WVZ506/. THESE CHANGES APPLY TO BOTH FIRE AND PUBLIC WEATHER ZONES.

CURRENTLY...THE FORECAST ZONES FOR HIGHLAND AND PENDLETON COUNTIES ENCOMPASS THE HIGHER ELEVATION AREAS ALONG AND AROUND THE ALLEGHENY FRONT RIDGE IN THE WEST...AS WELL AS THE MORE POPULATED LOWER LYING AREAS IN THE EAST. THREE US ROUTES PASS THROUGH THESE AREAS INCLUDING US-250...US-220 AND US-33.

BY SPLITTING THESE COUNTIES BASED ON TWO DISTINCT CLIMATE REGIMES INTO WESTERN AND EASTERN FORECAST ZONES...FORECAST AND WARNING SERVICES WILL BE IMPROVED IN THESE TWO COUNTIES. THE DIVIDE WILL FOLLOW THE RIDGELINE OF NORTH FORK MOUNTAIN SOUTH THROUGH PENDLETON COUNTY...CONTINUING ALONG THE RIDGELINE OF MONTEREY MOUNTAIN AND BACK CREEK MOUNTAIN IN HIGHLAND COUNTY.
