For Many Weather Forecast Offices in NWS Southern Region  
Effective December 18, 2013

Effective Wednesday, December 18, 2013, NWS will discontinue the Coded Cities Forecast (FPaa4i CCCC, CCFXXX) at Weather Forecast Offices (WFOs) in the NWS Southern Region (SR) listed below. NWS asked for comments regarding the CCF in July 2009:
