Subject: Change to Issuance Times of WPC Day 1-3 Quantitative Precipitation Forecasts for CONUS: Effective July 15, 2015

Effective Wednesday, July 15, 2015, at 1800 Coordinated Universal Time (UTC), the National Centers for Environmental Prediction (NCEP) Weather Prediction Center (WPC) will modify the issuance times of the Day 1, 2 and 3 Quantitative Precipitation Forecasts (QPF).

Currently, the WPC issues the above suite of QPF grids, graphics and text products for Days 1, 2 and 3 in 6-hour time steps. Six-hour forecasts are accumulated to produce graphics at 12-, 24-, 48-, and 72-hour periods. The Day 1 and 2 products are published four times per day and consist of two preliminary and two final issuances for each day, while the Day 3 products are published only twice per day; no preliminary forecasts are issued.

To promote consistency among the products and to foster collaboration with the NWS Weather Forecast Offices (WFOs) and River Forecast Centers (RFCs), the WPC will be modifying the issuance times of the QPF products and adding a preliminary Day 3 forecast. NCEP will continue to issue all preliminary Day 1 (forecast hour 00 to forecast hour 24) and Day 2 (forecast hour 24 to forecast hour 48) products at 0600/1800 UTC, with a final update issued at 0830/2030 UTC. The time between the initial and final products will be used to collaborate with NWS WFOs and RFCs and to review new model guidance.

For Day 3 (forecast hour 48 to forecast hour 72) products, NCEP will issue a new, preliminary version at 0600/1800 UTC and have the same deadline as the preliminary Day 1 and 2 forecasts. There also will be an update to the Day 3 products issued at 0830/2030 UTC, which is 30 minutes later than the current products. This change will allow the forecasters time to collaborate with the WFOs and RFCs.
