SUBJECT: Amended: New Fire and Public Forecast Zones for
Monongalia, Preston and Tucker Counties in West Virginia:
Effective November 10, 2015

Amended to change effective date to November 10, 2015.

Corrected to remove the Watch County Notification (WCN) product
from the list of affected products.

Effective Tuesday, November 10, 2015, at 1800 Coordinated
Universal Time (UTC), 1 pm Eastern Standard Time (EST), the NWS
Weather Forecast Office in Pittsburgh, PA (PBZ), will split its
fire and public forecast zones for Monongalia, Preston and
Tucker Counties in West Virginia. These changes will allow long
fused watches, warnings, advisories and forecasts for these
counties to be more geographically specific.

-Preston County (WVZ023) zone will be divided into three parts:
Ridges of Eastern Monongalia and Northwestern Preston (WVZ510)
Preston (WVZ511) and Eastern Preston (WVZ512)

-Tucker County (WVZ041) zone will be divided into western
(Western Tucker - WVZ513) and eastern (Eastern Tucker - WVZ514)
zones.

-Monongalia County (WVZ022) will be divided into two parts with
the eastern part of the county being combined with the
Northwestern Preston County zone (WVZ510), and the western part
of the zone maintaining its name, but being renumbered

(Monongalia - WVZ509).

The new zones will be assigned new zone names and numbers as shown in Table 1. These fire and public zone changes require partners and users to take appropriate action to receive the new zone products using the Universal Generic Code (UGC) zone code format (Z) listed in Table 1.
