Subject: Amended: Transfer of Tsunami Products for Puerto Rico
 and Virgin Islands from National Tsunami Warning Center
 (NTWC) to the Pacific Tsunami Warning Center (PTWC)
 Effective on a date to be determined (TBD)

Due to ongoing technical difficulties related to implementation
of this change, the effective date has been delayed
indefinitely. Once an effective date is determined, a follow-on
Service Change Notice reflecting that date will be issued.
Previously used WMO Header and AWIPS ID dissemination header
information associated with NTWC Tsunami products for Puerto
Rico and the U.S. and British Virgin Islands will remain in
place until the date of service transfer.

In order to improve consistency of services for the Caribbean,
responsibility for Tsunami Watch, Warning and Advisory Messages
and Tsunami Information Statements for Puerto Rico and the U.S.
and British Virgin Islands will be transferred from the National
Tsunami Warning Center (NTWC) to the Pacific Tsunami Warning
Center (PTWC). This transfer will be effective TBD.
