EFFECTIVE TUESDAY...APRIL 6 1999...AT 4:40 A.M. MOUNTAIN DAYLIGHT  
TIME...1040 COORDINATED UNIVERSAL TIME /UTC/...THE NATIONAL WEATHER  
SERVICE OFFICE /NWSO/ IN RIVERTON WYOMING /RIW/ WILL ASSUME FORECAST  
RESPONSIBILITY FOR TWENTY-SEVEN /27/ ZONES IN CENTRAL AND WESTERN WYOMING.
