AMENDED TO ANNOUNCE IMPLEMENTATION HAS BEEN RESCHEDULED.

TOMORROW/S PLANNED IMPLEMENTATION HAS BEEN RESCHEDULED UNTIL SEPTEMBER 20  
2005 AT 1400 COORDINATED UNIVERSAL TIME /UTC/...SEPTEMBER 21 AT MIDNIGHT  
LOCAL GUAM TIME. THIS DELAY IS DUE TO A CRITICAL WEATHER DAY IN EFFECT  
DUE TO TROPICAL STORM OPHELIA. DURING CRITICAL WEATHER DAYS...ROUTINE  
IMPLEMENTATIONS ARE POSTPONED.

TO REITERATE: SIX NDFD ELEMENTS FOR GUAM WILL NOW BE UPGRADED FROM  
EXPERIMENTAL TO OPERATIONAL STATUS ON SEPTEMBER 20 2005 AT 1400  
UTC...SEPTEMBER 21 AT MIDNIGHT LOCAL GUAM TIME. THIS IMPLEMENTATION WILL  
BE DELAYED AGAIN IF THE NEW IMPLEMENTATION DATE IS A CRITICAL WEATHER DAY.  
THE SIX ELEMENTS ARE:

TEMPERATURE  
MAXIMUM TEMPERATURE  
DEW POINT  
MINIMUM TEMPERATURE  
WEATHER  
12-HOUR PROBABILITY OF PRECIPITATION
