GRIFFISS AIRPARK /KRME/ ON OR ABOUT DECEMBER 31 2006.

/UTC/...NWS WILL NO LONGER ISSUE PRODUCTS ASSOCIATED WITH ONEIDA COUNTY

/UTC/...THE NWS WILL BEGIN ISSUING SELECTED PRODUCTS FOR GRIFFISS AIRPARK

TERMINAL AERODROME FORECAST /TAF/ SERVICE FOR KRME WILL BEGIN ON DECEMBER  
27 2006 TO GIVE CUSTOMERS AMPLE TIME TO DEVELOP CONTINUITY WITH THE NEW
