EFFECTIVE WEDNESDAY MAY 16 AT 1200 COORDINATED UNIVERSAL TIME /UTC/...THE  
NWS OFFICE IN BURLINGTON VERMONT WILL BEGIN TAF SERVICE FOR THE  
PLATTSBURGH INTERNATIONAL AIRPORT /KPBG/ NEAR PLATTSBURGH NY. ROUTINE AND  
UPDATED TAFS WILL BE ISSUED FOR THIS AIRPORT 24 HOURS PER DAY.
