EFFECTIVE JANUARY 29 2008...BEGINNING WITH THE 1200 COORDINATED UNIVERSAL TIME /UTC/ RUN...ALL NATIONAL CENTERS FOR ENVIRONMENTAL PREDICTION /NCEP/ MODEL GRIDDED BINARY VERSION ONE /GRIB1/ PRODUCTS ON THE NWS TELECOMMUNICATIONS GATEWAY /NWSTG/ AND NCEP PUBLIC FILE TRANSFER PROTOCOL /FTP/ SERVERS WILL BE REMOVED. THEY WILL BE REPLACED WITH GRIDDED BINARY VERSION TWO /GRIB2/ PRODUCTS. THE SIGNIFICANT BENEFIT OF THIS CHANGE IS THE SAVINGS OF BANDWIDTH AND DISK SPACE USED FOR BOTH THE GOVERNMENT AND PUBLIC/PRIVATE USERS.
