AND NGM-BASED PRODUCTS. NGM-BASED PRODUCTS INCLUDE NGM MODEL
OUTPUT STATISTICS /MOS/...NATIONAL CENTERS FOR ENVIRONMENTAL
PREDICTION /NCEP/-BASED PRODUCTS AND A TRAJECTORY MODEL PROVIDED
BY THE METEOROLOGICAL DEVELOPMENT LABORATORY /MDL/.
