THE NWS WILL TEST A CHANGE TO THE NAME OF THE OAKLAND OCEANIC FLIGHT INFORMATION REGION /FIR/ FOR /KZOA/ JUNE 3 2010 AT 1600 COORDINATED UNIVERSAL TIME /UTC/. DURING THIS TEST...THE LARGE OCEANIC FIR WILL BE RENAMED KZAK FOR THE PURPOSE OF A SIGNIFICANT METEOROLOGICAL INFORMATION /SIGMET/ TEST. MEANWHILE...THE SMALLER AREA AROUND THE OAKLAND AIRSPACE OVER LAND AND THE IMMEDIATE COAST WILL RETAIN THE NAME KZOA.

THE MAIN PURPOSE OF THE TEST IS TO ENSURE THAT FEDERAL AVIATION ADMINISTRATION /FAA/ SYSTEMS /OASIS AND AISR/ CAN HANDLE THE U.S. SIGMET HEADER CHANGE.

BELOW IS AN EXAMPLE OF A SIGMET FOR THIS TEST FROM THE HONOLULU METEOROLOGICAL WATCH OFFICE. AT THE BEGINNING OF THE FIRST LINE...THE CURRENT NOTATION KZOA FOR THE LARGE OCEANIC FIR WILL BE REPLACED BY KZAK:
