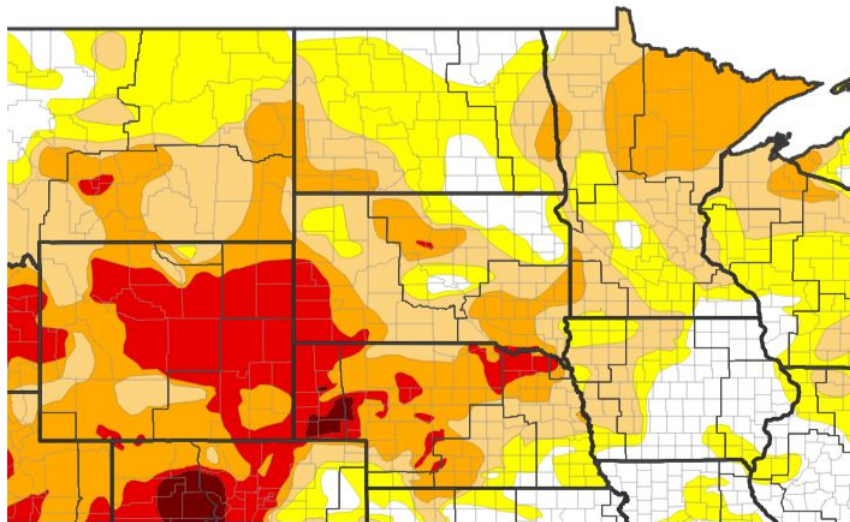

Drought intensity and Extent

- **D4 (Exceptional Drought):** not occurring
- **D3 (Extreme Drought):** portions of Campbell, Crook, Weston, Butte, Lawrence, Meade, Pennington, Custer, Fall River, Oglala Lakota, and Bennett Counties.
- **D2 (Severe Drought):** portions of Campbell, Crook, Butte, Meade, Pennington, Custer, Oglala Lakota, Jackson, Bennett, and Ziebach Counties.
- **D1 (Moderate Drought):** portions of Harding, Butte, Perkins, Ziebach, Meade, Pennington, Haakon, Jackson, Bennett, Mellette, Todd, and Tripp Counties.
- **D0: (Abnormally Dry):** portions of Harding, Butte, Meade, and Perkins Counties.

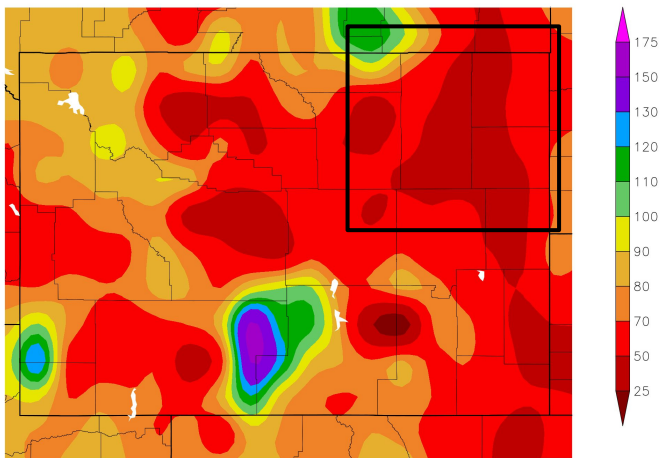

1/1/2026 – 7/29/2026

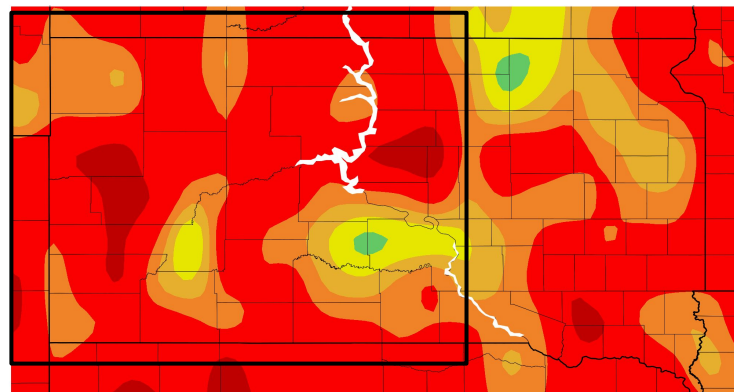

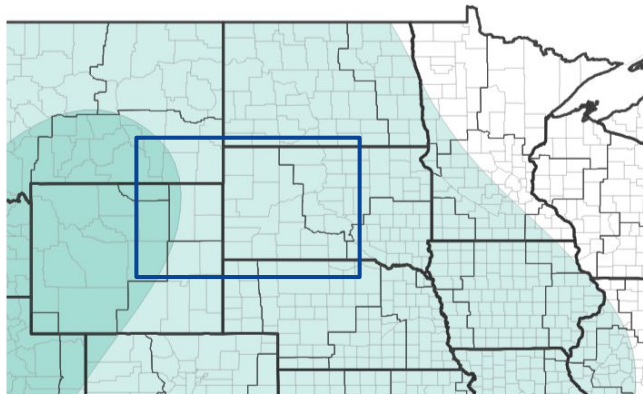


Long-Range Outlooks

- There is a greater chance for above average precipitation in August. However, precipitation will be localized from thunderstorms which is common in August.
- Odds favor slightly below average temperatures across portions of northwest South Dakota and northeastern Wyoming.

Monthly Precipitation Outlook for August 1, 2026–August 31, 2026



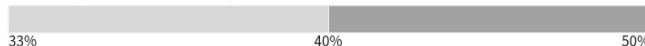
Probability of Below-Normal Precipitation



Probability of Above-Normal Precipitation

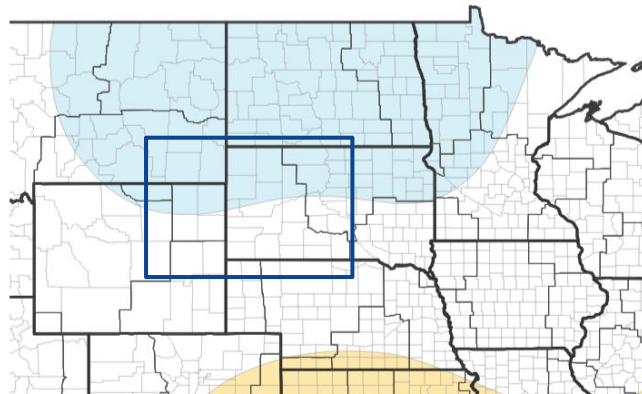


Probability of Near-Normal Precipitation

Monthly Temperature Outlook for August 1, 2026–August 31, 2026



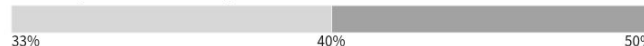
Probability of Below-Normal Temperatures

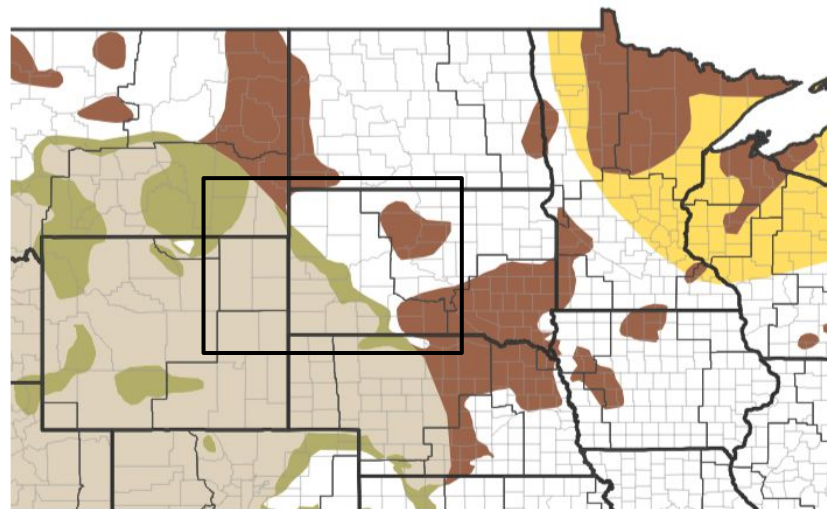


Drought Outlook
